# Every child deserves proper care and protection

The Department of Social Development Child Care & Protection Programme provides quality services to children who:

- Need care and protection;
- Have special needs (this can include chronic illnesses, disabilities and those children who display behaviours that are difficult to manage).

Through this programme the Department is committed to building families and communities that care and protect children in order to reach their full potential.



4. The right to participate in decision-making that will have an effect on them.
5. We have a responsibility to report child abuse cases and always act in the best interests of the child.

## What we do

- Public education about rights and responsibilities of parents, caregivers and/or families whose children have been placed in alternative care;
- Programmes for children and adolescents with behavioural challenges;
- Support for children once they leave foster care, Child and Youth Care Centres, and temporary 'safe' shelters. This support includes help with CV writing, job hunting, and opening a bank account;
- Facilitate reintegration and reunification, and help families to sustain the relationships after children are placed with carers;
- Prevention and early intervention programmes –
  - Support to families with children in order to strengthen and build their ability to address problems that occur in the family environment;
  - Early intervention programmes are provided to families with children identified as being vulnerable or at risk of harm or of removal to alternative care; and
- Enforce legislation that focuses on child safety..

## Know your rights

Children have a right to be protected and cared for!

The Children's Act ensures a number of rights which all children are afforded:

1. The right to basic nutrition, shelter, basic health-care services and social services.
2. The right to family and protective care.
3. The right to be protected from maltreatment, neglect, abuse and degradation.

- Voorkoming- en Vroeë-intervensieprogramme :

## Ken jou regte

Kinders het die reg om beskerm en versorg te word!

Die Kinderwet gee aan alle kinders sekere regte:

1. Elke kind het die reg tot basiese voeding, skuiling, gesondheidsorg- en maatskaplike dienste,
2. Elke kind het die reg tot gesin- en beskermingsorg,
3. Elke kind het die reg om teen mishandeling, verwaarloosing, misbruik en vernedering beskerm te word,
4. Elke kind het die reg om aan besluitneming deel te neem wat hulle raak,
5. Ons het die verantwoordelikheid om gevalle kan kindermishandeling aan te meld en om altyd in die beste belang van die kind op te tree

## Elke kind verdien behoorlike versorging en beskerming

Die Kindersorg- en beskermingsprogram van die Departement van Maatskaplike Ontwikkeling verskaf gehalte dienste aan kinders en sluit in:

- Sorg en beskerming,
- Kinders met spesiale behoeftes (dit kan chroniese siektes, gestremdhede en kinders insluit wat gedrag openbaar wat moeilik is om te beheer).

Die program is verbind tot die (op)bou van gesinne en gemeenskappe wat hulle kinders versorg en beskerm sodat hulle hul volle potensiaal kan bereik.

- Openbare opvoeding- en voorkomingsprogramme wat fokus op die regte en verantwoordelikhede van ouers, versorgers en/of gesinne wie se kinders in alternatiewe sorg geplaas is,
- Programme vir kinders en adolossente met riskante en gedragsuitdagings,
- Steunprogramme vir kinders wat pleegsorg verlaat het,
- Kinder- en Jeugsorgsentra en tydelike 'veilige' skuilings - dienste sluit in bystand met basiese vaardighede soos die skryf van 'n CV, werkgeleenthede en die opening van 'n bankrekening in,
- Fasiliteer herintegrasie en hereniging, en ondersteun
