Taking pet dogs and cats to Australia

If your situation differs in any way from the proposed process, or if you have information from the veterinary authority of the importing country that differs from the process described below, please contact your local state veterinarian to discuss the matter.

Exporters are advised to verify the requirements of the importing country by contacting the veterinary authorities, or their representatives in South Africa, in advance of each consignment.

In South Africa all veterinarians registered with the South African Veterinary Council are authorised to perform the procedures needed for the export of dogs and cats to Australia.

All testing must be done in an approved country in a laboratory recognised by the government of the country of export. It is acceptable to draw blood in South Africa and test it at a laboratory in a different approved country. Evidence that the laboratory is an OIE laboratory will need to be provided by the client should they choose to use a lab other than the Onderstepoort Veterinary Institute (OVI).

Requirements

You will need to apply for an import permit. Please have a look at this website for detailed step by step guides:

This document is to aid the authorised veterinarian in keeping all the information in one place and in an easy to understand format. The veterinarian will still need to complete the Australian documentation but this will help with the collation of the information needed.

Identification of the animals

A government approved veterinarian must scan the microchip at each veterinary visit. The scanned microchip number must be correctly recorded on all documentation.

If an identity verification, including scanning of the microchip, is carried out by a state veterinarian of South Africa as part of the import permit application process, the animal may

be eligible for a 10 day post entry quarantine (PEQ) period; if not, the animal will require at least a 30 day PEQ period.

If at any point in the process the microchip cannot be read or is recorded incorrectly in the animals documentation the animal will not be exported to Australia

Once the Rabies test and vaccination is completed the state vet will need to sign the RNAT test declaration before you are able to apply for the import permit.

Procedure

- Your veterinarian should complete the veterinary health certificate specifically for Australia (VHC). Blank forms may be obtained from the State Veterinary office (SV) or our website www.elsenburg.com.
- The signed VHC as well as your pet's vaccination booklet and supporting documents should be brought to the SV office for certification. You should also have your driver's licence or ID book available.
- Certificates cost can be found on the departments schedule of fees (Cost in 2023 is R209 each) payable before or at the appointment.

Identification declaration for dogs and cats travelling to Australia

Department of Agriculture, Fisheries and Forestry (Australia) announced that the new import conditions for dogs and cats travelling to Australia is implemented from 1 March 2023.

According to their notification, Identification Declaration may be completed as part of the import permit application for dogs and cats being imported to Australia from approved group 3 countries. South Africa is listed in their approved group 3 countries.

Please note that this procedure may change depending on the outcome of bilateral negotiation between South Africa and Australia.

Requirements

- A valid microchip certificate. All dogs and cats must be implanted with an International Organization for Standardisation (ISO) compatible microchip prior to commencing pre-export preparation.
- Pet's vaccination booklet with animal details such as name, date of birth, sex, etc.
- The identity verification must occur before a blood sample is collected for RNAT testing, and at least 180 days before export to Australia.

Procedure for identity verification by a state veterinarian.

- Your pet should be taken to your local state veterinarian for an identity verification and scanning of the microchip.
- Your pet's vaccination booklet and microchip certificate should be brought to the SV office for verification.
- The client needs to sign the indemnity form before scanning of the microchip is carried out. (Indemnity form can be found on page 11 of this document). Our facilities are not suited to do this procedure and the microchip scanning may be done outside or in the open unenclosed garden. The client is responsible to handle/restrain the pet.
- State veterinarian should complete the identification declaration form specifically for Australia after scanning the microchip. Blank forms may be obtained from the State Veterinary office (SV) or our website www.elsenburg.com
- State veterinarian must forward the completed identification declaration form to the Department of Agriculture, Fisheries and Forestry at catdogidcheck@agriculture.gov.au. The email must include the following information in the subject line: Importer surname, importer first name, animal name, microchip number, country of export (e.g. Smith, Jenny, Bella 123456789, and South Africa). The client must be copied in on the e-mail.
- The original signed identification declaration form can be given to the owner of the animal.
- You should have your driver's licence or ID book available.
- Certificate costs can be found on the departments schedule of fees (Cost in 2023 is R209 each) payable before or at the appointment.
